A POLICY FRAMEWORK FOR LIMITED AUTOMOBILE ENTRY IN THE CAMPUS

Purpose:

Chaitanya Science and Arts College recognizes the need to promote sustainable and eco-friendly practices on campus. Policy Statements:

1. Limited Automobile Entry
